

Government Performance and Results Act (GPRA) Client Outcome Measures for Discretionary Programs Tool (GPRA Tool) (if applicable)

CSAT client-level data includes the Government Performance and Results Act (GPRA) Client Outcome Measures for Discretionary Programs Tool (GPRA Tool) for data collection. CSAT GPRA Tool interviews must be conducted with clients at intake/baseline, discharge, and 6-month follow-up. Some CSAT-designated programs are also required to conduct a 3-month follow-up interview.

# Data Entry, Reports, and Additional Resources



## **ENTERING DATA (continued)**

State Opioid Response/Tribal Opioid Response (SOR/TOR) Program Instrument (if applicable)

Some CSAT grantees are also required to collect program-level data. State Opioid Response (SOR) and Tribal Opioid Response (TOR) grantees collect services and program-level data which is reported on a quarterly basis. The Notice of Award (NOA) and the grant's GPO will outline these requirements (if applicable.

ACCESSING AND USING REPORTS
The grantee has reviewed the <u>CSAT data visualization</u> homepage where they can select from a range of reports an ilters to generate charts and information based on their data. #### **GETTING HELP**

- GPOs should ensure grantees are aware the SPARS Help Desk (<u>SPARSHelpDesk@mathematica-mpr.com</u> or 1-800-685-7623) can help with fixing account issues, finding information on how to use data entry and reporting features in SPARS, solving problems with the website, and locating resources.
- GPOs should ensure grantees are aware that they can submit Technical Support Request System (TSRS) requests
  using the Technical Support tab on the homepage. Examples of technical support include requests for improving
  follow-up rates, using data in reports, or creating graphics to promote grant programs. Learn more about TSRS

- The grantee is aware they can reach out to their GPO for other questions.
