

Explanation of CMHS NOMS Codebook Elements for combined new NOMs tool

Note: This CMHS NOMS Codebook is being released to aid grantees in understanding the new tool and in transitioning their own systems and practices to accommodate the new tool. While the codebook is as accurate as we can make it at this time, there may be changes required as the new NOMS tool is finalized and tested in the SPARS system. While we expect any such changes to be minor, please watch for updates to this codebook in the future.

Overview: This CMHS NOMS Codebook contains information about the fields available for batch upload and data download for the new NOMS tool used for client-level interviews from 12/10/2022 and forward. Grantees should refer to the previous iteration of the adult and child codebooks for the expired adult and child tool records. This codebook should only be used for the combined new NOMs tool.

Codebook columns: Columns A and B indicate if a particular row/field is used for batch upload and/or appears in data download. Grantees should filter based on these columns to determine all the fields needed for batch upload and all the fields to expect in a data download.

Column C indicates the section of the tool that particular row/field appears in the NOMs tool.

Column D indicates the question number that particular row/field appears as in the NOMs tool.

Column E indicates the question text that particular row/field appears as in the NOMs tool.

Column F indicates the possible responses as it appears in the NOMs tool (English version).

Column G indicates data type for that particular row/field.

Column H indicates the field name that should be used for batch upload and the name that appears in data download for questions related to the new NOMs tool. Note that not all field names appear in the tool as some are system derived.

Columns I and J should be referenced to determine the valid values that can be used for batch upload and the valid values to expect when viewing a data download file.

Column K indicates additional notes related to warnings, skip logic, and conditions for that particular row/field.

Codebook rows: There is a row in the codebook for every field that will appear in the data download, or is used to batch upload data, for the new NOMs tool. Downloads for expired adult tool data or child tool data should use the previous versions of the CMHS NOMs codebooks for those tools.
